

## DESCRIPTION OF SURVEY FOR JEFF MOORE

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Northeast Quarter, of Section #20, Township #15, Range #14, of the Congress Lands East of the Scioto River, being part of the prior deed reference Volume 738, Page 236 of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 47-47-70-20-04-000, and more particularly described as follows;

Commencing at an iron pin (found) capped RLS #5410 at the Northwest corner of the Northeast Quarter of said Section #20, said pin being within the road bed of Stiers Lane (Township Road #127); thence S 87 24 40 E 450.00 feet along the North line of said Section #20 as shown on a survey of the prior deed reference Volume 738, Volume 236 completed on 2/11/93 by RS #5410 R. L. Daniels to a point approximately 13 feet South of the center line of said Stiers Lane and being the place of beginning for the property herein intended to be described;

- #1- thence S 87 24 40 E 571.04 feet continuing along the North line of Section #20 as shown of said Daniels' survey to a railroad spike (found) in the center of Huggins Road (Township Road #89), passing an iron pin (found) capped RLS #5410 at 551.04 feet;
- #2- thence S 08 15 15 E 529.57 feet through said prior deed reference and along the center line of said Huggins Road as shown on said Daniels' survey to a point;
- #3- thence S 14 19 25 E 97.38 feet continuing through said prior deed reference and along the center line of said Huggins Road as shown on said Daniels' survey to a point;
- #4- thence S 03 27 00 E 46.47 feet continuing through said prior deed reference and along the center line of said Huggins Road as shown on said Daniels' survey to a point;
- #5- thence S 03 47 45 W 20.55 feet continuing through said prior deed reference and along the center line of said Huggins Road as shown on said Daniels' survey to a point;
- #6- thence N 87 34 10 W 708.00 feet continuing through said prior deed reference and leaving said road to an iron pin (set), passing an iron pin (set) at 15.00 feet;
- #7- thence N 02 58 15 E 682.00 feet continuing through said prior deed reference to the place of beginning, passing an iron pin (set) at 672.00 feet, containing 10.00 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).


