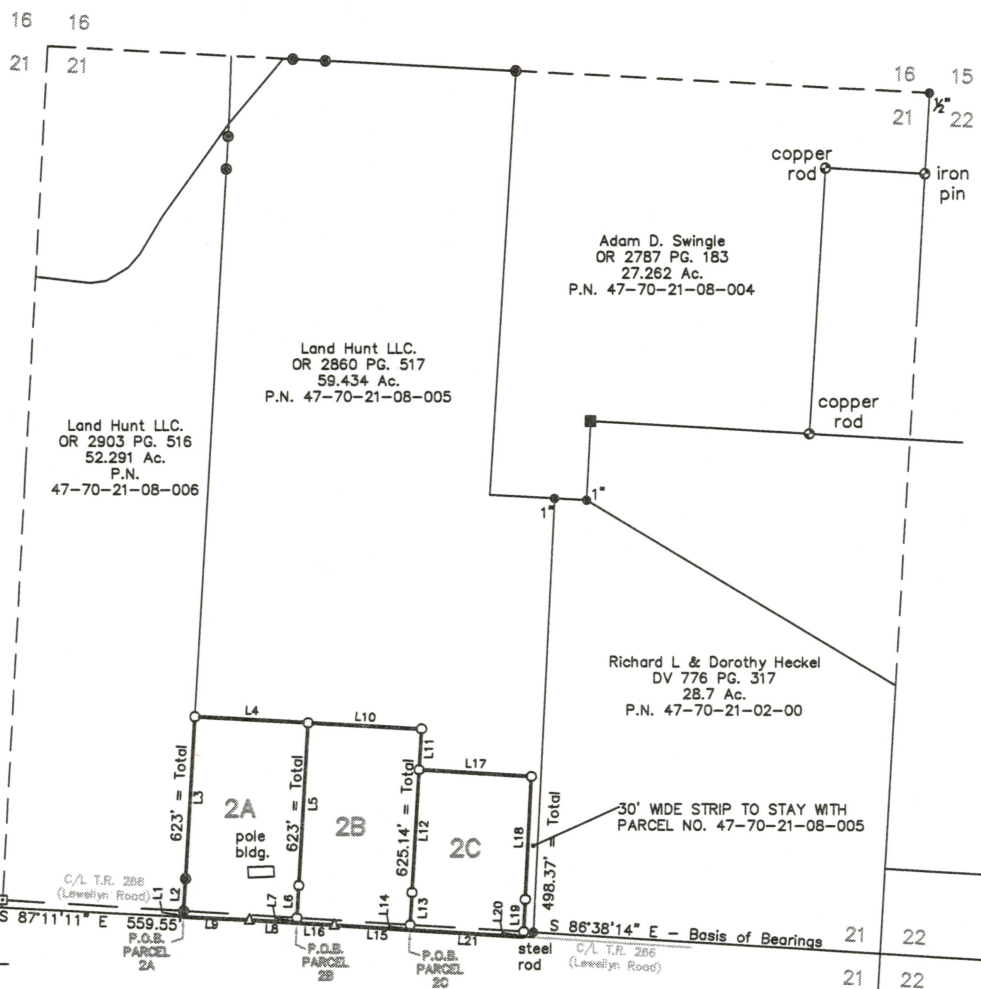


Survey Plat for Mark Vensil

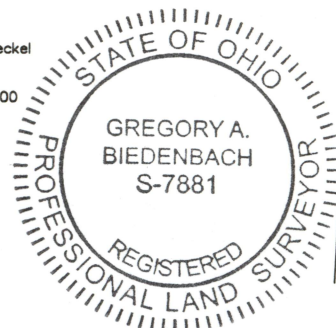
