Beginning at a stone at the Southeast Corner of the Southwest Quarter of Section 36; thence along the Muskingum & Perry County Line North 86Degrees 36 Minutes 04 Seconds West 1164.98 feet to an iron pin found, passing an iron pin found at 619.29 feet; thence North 11 Degrees 37 Minutes 03 Seconds West 651.58 feet to a point in the centerline of Twp. Rd. 268, passing an iron pin found at 636.58 feet; thence along said centerline the next 3 courses to points: North 66 Degrees 45 Minutes 37 Seconds East 176.56 feet; thence North 62 Degrees 31 Minutes 12 Seconds East 205.24 feet; thence North 61 Degrees 37 Minutes 29 Seconds East 108.76 feet; thence leaving said centerline South 20 Degrees 42 minutes 45 Seconds East 344.03 feet to an iron pin found, passing an iron pin set at 15.00 feet; thence South 14 Degrees 36 Minutes 42 Seconds East 128.63 feet to an iron pin found; thence North 55 Degrees 25 Minutes 12 Seconds East 160.52 feet to an iron pin found; thence South 12 Degrees 17 Minutes 58 Seconds East 52.44 feet to an iron pin found; thence North 76 Degrees 46 Minutes 19 Seconds East 618.31 feet to a point in Butcher knife Creek; thence South 03 Degrees 55 Minutes 45 Seconds West 660.00 feet to the place of beginning, containing 18.126 acres, more or less, subject to all legal highways and easements.
