Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, part of the Northeast Quarter of Section 28, and bounded and described as follows:

Commencing at a stone found at the Northeast corner of the Northeast Quarter of Section 28; thence South $0^{\circ} 00' 00''$ East on the East line of said quarter section 1120.17 feet to an iron pin found; thence leaving quarter section line South $86^{\circ} 54' 38''$ West 277.88 feet to a point in Harlan Road, the place of beginning; thence leaving Harlan Road South $4^{\circ} 22' 30''$ West 402.12 feet to an iron pin, passing an iron pin at 16.45 feet; thence North $85^{\circ} 37' 30''$ West 542.26 feet to an iron pin; thence North $4^{\circ} 22' 30''$ East 400.28 feet to the center of Harlan Road, passing an iron pin at 385.67 feet; thence South $86^{\circ} 10' 58''$ East 188.62 feet to a point in Harlan Road from which an iron pin bears South $30^{\circ} 18' 30''$ East 20.00 feet; thence along the center of Harlan Road South $85^{\circ} 37' 30''$ East 353.64 feet to the place of beginning, containing 5.00 acres more or less.

Bearings are based on the East line of the Northeast Quarter of Section 28 bearing South $0^{\circ} 00' 00''$ East.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic T. D. caps.

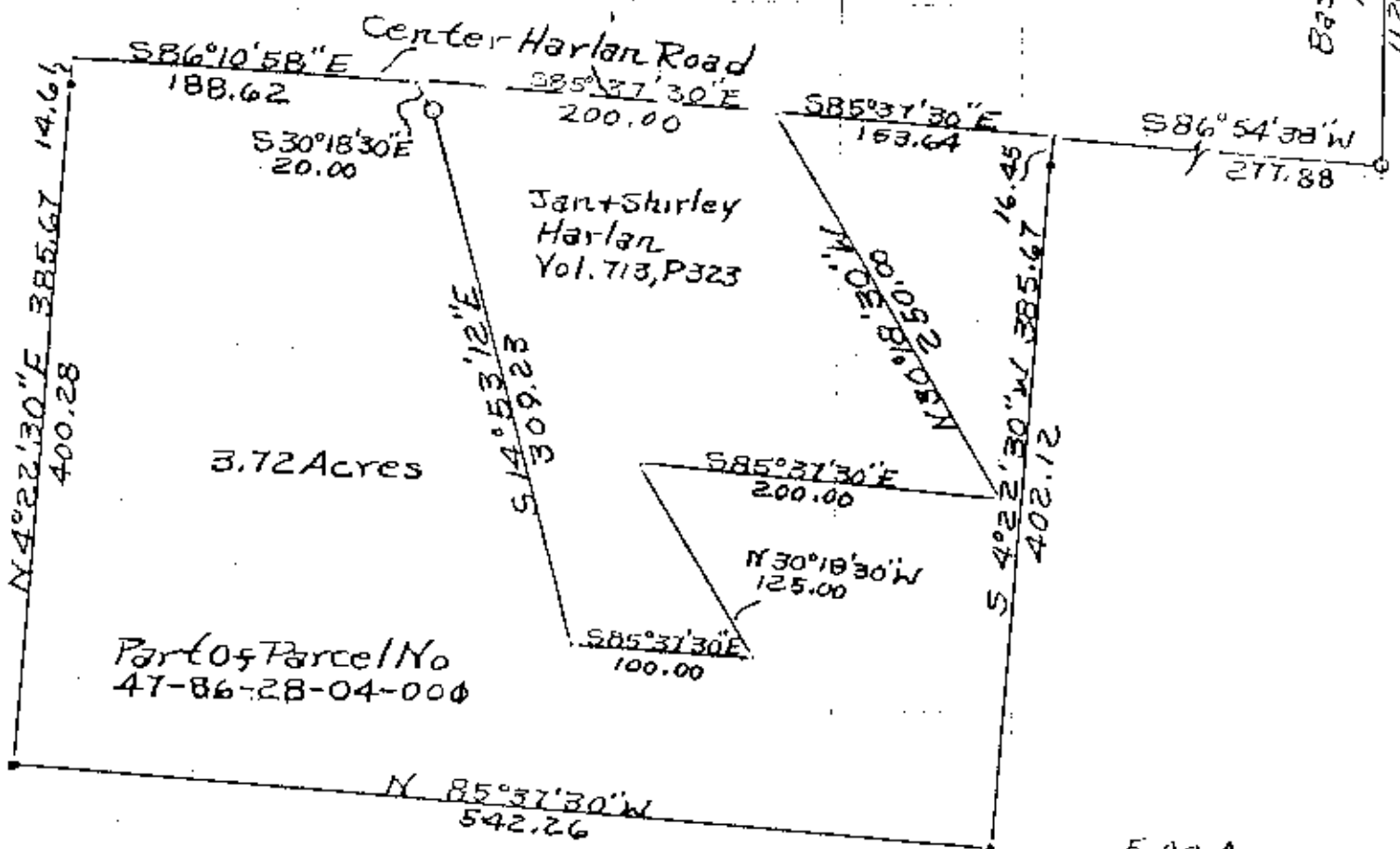
