

- #20- THENCE South 57 degrees 42 minutes 11 seconds East 33.59 feet continuing within said roadbed and along said properties to an unmarked point on the common line for Sections 20 and 21 of Newton Township and said Township and Range, from which an iron pin (found capped 7113 Linn) for reference bears North 21 degrees 21 minutes 21 seconds East 26.44 feet;
