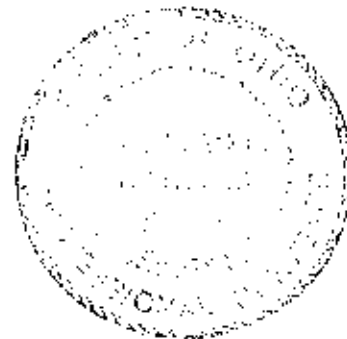
Iron pins set are NO. 5 reinforced bars 30 inches long with plastic ID caps.
