Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, Section 34, bounded and described as follows:

Being part of Deed Vol. 463, Page 382, Parcel Nos. 47-92-02-04-000 and 47-92-02-02-000.

Commencing at an iron pin found at the Northwest Corner of the Southeast Quarter of Section 34; Thence North  $89^{\circ}59'35''$  East 488.00 feet to an iron pin set to the place of beginning; Thence North  $89^{\circ}59'35''$  East 545.07 feet along Russell Spring Jr. Vol. 1037, Page 54 and said section line to the center of the Moxahala Creek passing an iron pin set at 495.07 feet; Thence along center of Moxahala Creek the next five courses and distances South  $5^{\circ}33'16''$  East 109.40 feet to a point, South  $3^{\circ}52'42''$  West 61.42 feet to a point, South  $56^{\circ}14'28''$  West 63.93 feet to a point, South  $83^{\circ}21'30''$  West 206.90 feet to a point, and South  $81^{\circ}56'28''$  West 352.19 feet to a point; Thence leaving said creek and along Rosie Desarro et al. Vol. 952, Page 49 North  $11^{\circ}19'35''$  East 284.47 feet to the place of beginning containing 3.11 Acres more or less.

Bearings are based on the South line of the Northeast quarter of Section 34 bearing North  $89^{\circ}59'35''$  East.


Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.


