Note #4- Access denied through the Timothy Duff and Adam Prichard property to evaluate surveyed Quarter Section Line.

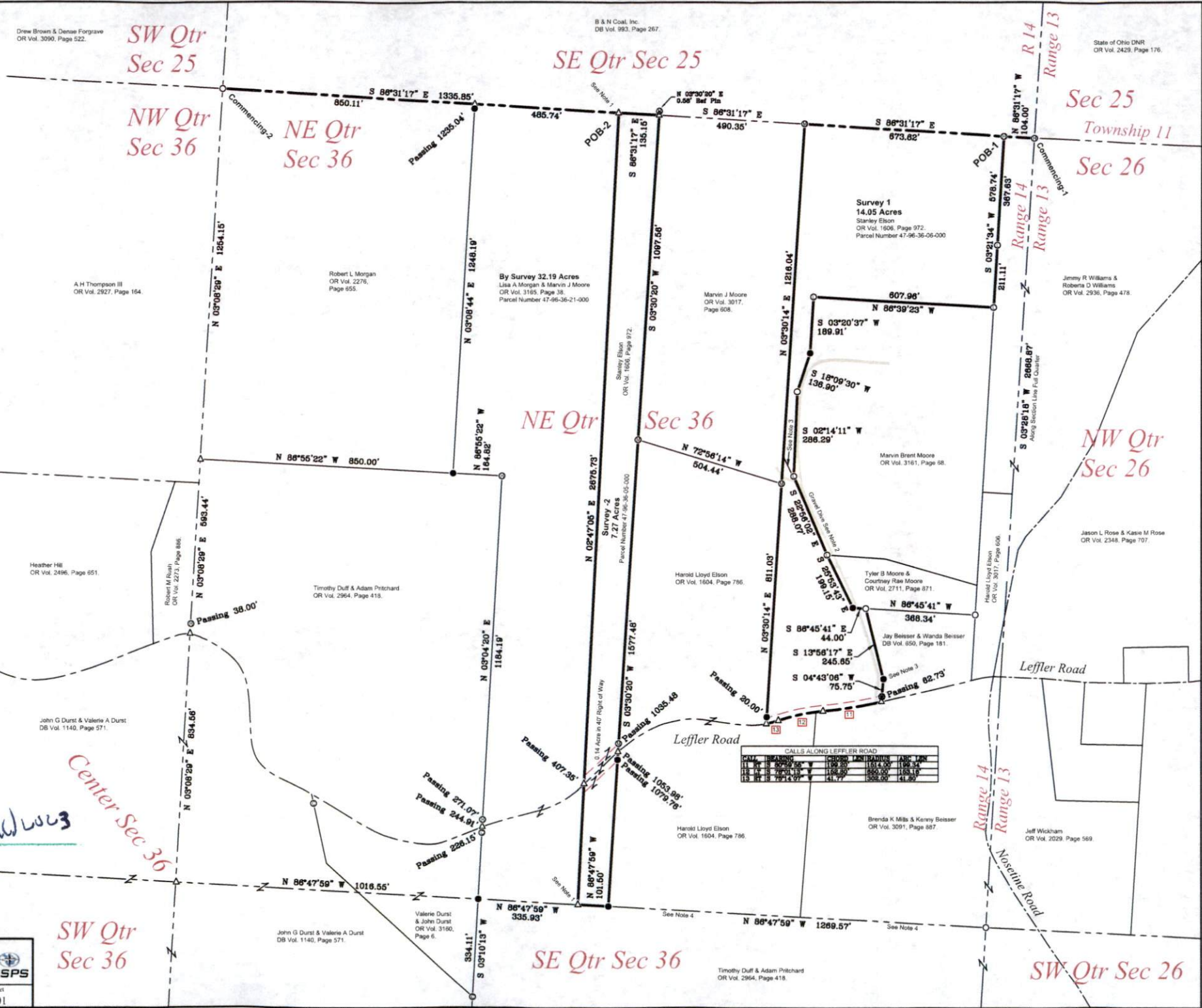
