

DESCRIPTION OF A 16.597 ACRE TRACT

Situate in the State of Ohio, County of Muskingum, Township of Perry, and being part of the Northwest Quarter of Section # 6, in the Second Quarter of Township 1 North, Range 6 West in the United States Military District and being part of the Elvin R. and Frances Culp property recorded in Volume # 1683, Page 253, part of Parcel # 51-01-06-15 and part of Parcel # 51-01-06-16 of Muskingum County records and being more particularly described as follows ;

Beginning at a stone found at the Northwest corner of the Northwest Quarter of Section # 6 , in the Second Quarter Township, Township 1 North, Range 6 West, thence along the Section line North 88 degrees 54 minutes 39 seconds East 1022.94 feet to an iron pin set ; thence along a new line South 06 degrees 38 minutes 30 seconds West 850.61 feet to an iron pin found ; thence along a Michael Culp property (Vol. 1827, Pg. 778) , North 77 degrees 51 minutes 57 seconds West 952.73 feet to an iron pin found ; thence along the Township line North 00 degrees 38 minutes 52 seconds East 625.23 feet to a stone found at the Place of Beginning.

Containing 16.597 acres , more or less, 12.134 acres of Parcel # 51-01-06-16 and 4.463 acres of Parcel # 51-01-06-15, subject to all easements , restrictions , or right of ways , either written or implied. All iron pins set are # 5 rebar 30 inches long with a yellow I.D. cap labeled "BINCKLEY S - 7879" .

Bearings on this description are based on a previous survey by Binckley Land Surveying dated 3-28-2000 and assume the Township line as being North 00 degrees 38 minutes 52 seconds East and are for angular calculation only.


