(RePlat 1, Pg. 36) in the southwest quarter of Section 6, T1, R6 and also being part of the lands now owned by Joseph P. Culp (OR 2615-231) of the Muskingum County Recorders Office and more particularly described as follows.

Beginning for reference at the northwest corner of Lot 1, Bower's Farm Sub. (Re-Plat 1, Page 36) and going with the north line of said Lot, South 88 degrees 05 minutes 48 seconds East, 642.94 feet to a point and the principal place of beginning;

thence continuing with the north line of said Lot 1, South 88 degrees 05 minutes 48 seconds East, 63.66 feet to a point on the northwest corner of the lands now owned by Cynthia J. Culp (OR 2569-140);

thence with the west line of said Cynthia J. Culp's lands, South 01 degrees 15 minutes 21 seconds West, 165.50 feet to an iron pin set;

thence going through said Joseph P. Culp's lands, North 19 degrees 41 minutes 51 seconds West, 177.99 feet to the place of beginning, passing an iron pin set at 176.91 feet, containing 0.121 acres more or less, subject to all legal highways and easements of record.

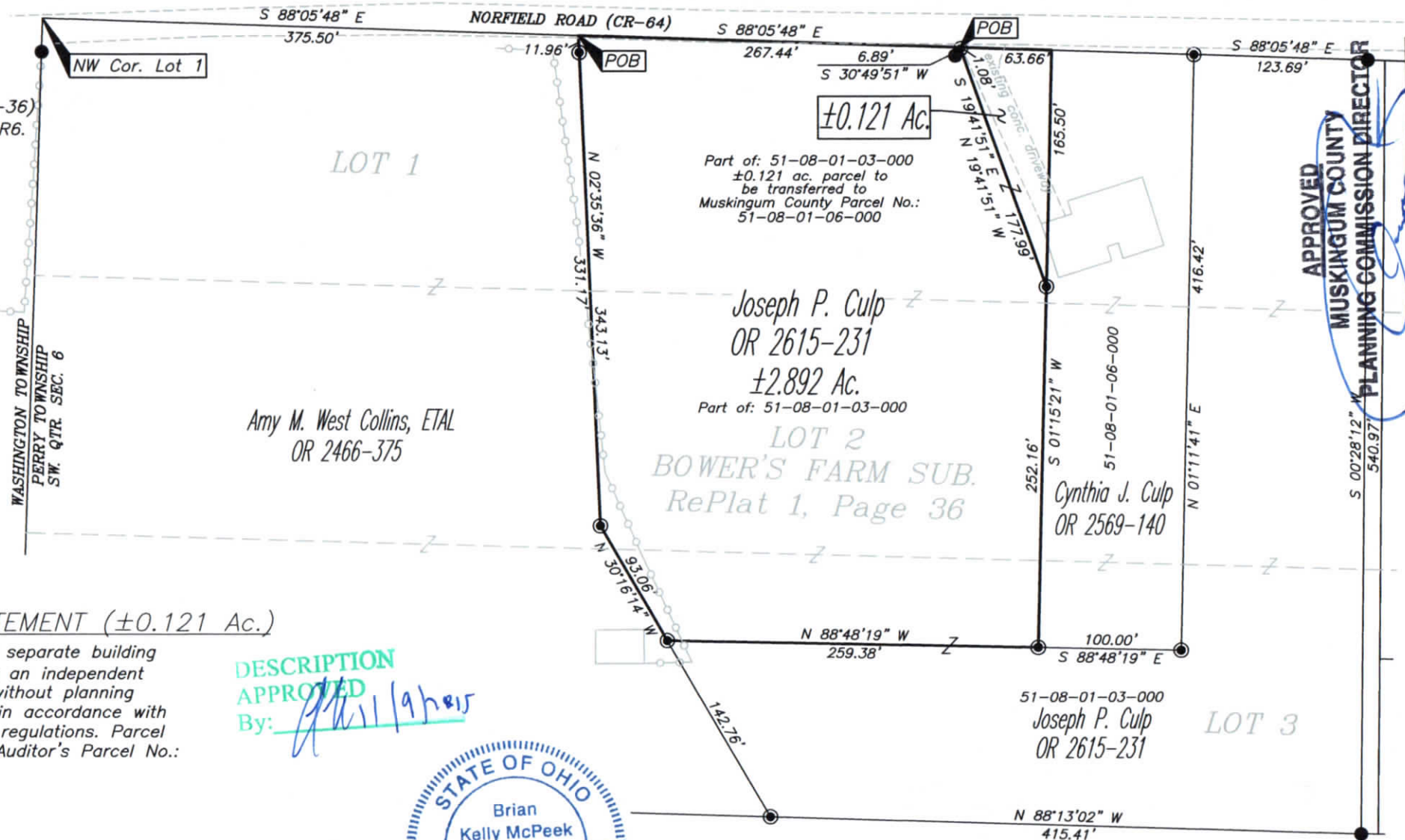

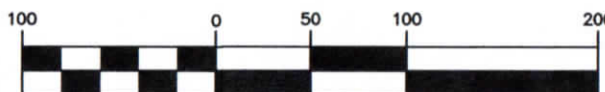
