Commencing at an iron pin found at the northeast corner of said Lot 4; thence along the east line of said Lot 4 south 1 degree 10 minutes 05 seconds west 307.58 feet to an iron pin found and the true place of beginning of the premises herein intended to be described; thence continuing south 1 degree 10 minutes 05 seconds west 165.16 feet to the southeast corner of said Lot 4; thence along the south line of said Lot 4 and the north line of Webster Street north 87 degrees 52 minutes 15 seconds west 288.26 feet to an iron pin; thence north 3 degrees 10 minutes 36 seconds west 165.79 feet to an iron pin on the south line of a 4.17 acre parcel conveyed to Paul D. Leasure and Mary J. Leasure by deed recorded in Deed Book 786, Page 15; thence along the south line of said 4.17 acre parcel and said line extended south 87 degrees 52 minutes 55 seconds east 300.82 feet to the true place of beginning, containing one and twelve hundredths (1.12) acres more or less.



