Being a part of the East Half of Section 12, Township one, Range six, Perry Township, Muskingum County, Ohio and being further described as follows:

Commencing at the Southeast Corner of the North Half of the South East Quarter of Section 12; thence North 00 degrees 06 minutes 19 seconds West 1235.55 feet along the East Line of Section 12 to a point being the Northeast Corner of the Southeast Quarter of Section 12, also passing a point marked by an iron pin at 820.41 feet; thence leaving the said East Line North 89 degrees 27 minutes 47 seconds West 1544.34 feet to a point marked by an iron pin, said point being the place of beginning of this tract; thence North 88 degrees 49 minutes 12 seconds West 256.87 feet to a point marked by a wood post; thence South 69 degrees 58 minutes 07 seconds West 282.78 feet to a point, passing a point marked by an iron pin at 170.14 feet; thence North 32 degrees 50 minutes 59 seconds East 107.78 feet to a point; thence North 89 degrees 27 minutes 06 seconds West 204.58 feet to a point; thence North 12 degrees 03 minutes 50 seconds West 211.88 feet to a point in the center of State Route forty; thence North 09 degrees 36 minutes 04 seconds East 401.03 feet to a point in the center of State Route forty; thence with a curve to the right having a radius of 2291.85 feet (chord Bearing North 09 degrees 50 minutes 02 seconds East 19.26 feet) an arc distance of 19.26 feet to a point in the center of the said State Route forty; thence South 34 degrees 53 minutes 54 seconds East 457.92 feet to the place of beginning, passing a point marked by an iron pin at 95.13 feet.

Containing 4.229 more or less acres, with 0.871 more or less acres in the right of way of State Route forty. \pm 0.211 Ac in the North Half of The S.E. Qtr Section 12.


