Beginning at an iron pin at the northeast corner of Lot 22; thence along the east line of said Lot 22 on a curve to the right having a radius of 532.73 feet an arc distance of 100 feet (the chord of which bears south 22 degrees 29 minutes 54 seconds west 99.85 feet) to an iron pin at the southeast corner of Lot 22; thence along the east line of Lot 21 south 27 degrees 52 minutes 33 seconds west 7.98 feet to an iron pin; thence north 62 degrees 07 minutes 27 seconds west 224.27 feet to an iron pin; thence north 25 degrees 25 minutes 44 seconds east 75.78 feet to an iron pin; thence south 70 degrees 23 minutes 16 seconds east 220.44 feet to the place of beginning, containing 20,545 square feet (0.47 acre) more or less.


