NORTH 08 DEGREES 14 MINUTES 54 SECONDS WEST 474.00 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR "BIEDENBACH" CAP FOUND DISTURBED AND RESET) AT THE NORTHEAST CORNER OF LOT 19 ON THE NORTH LINE OF SECTION 23, PASSING EXISTING IRON PINS (5/8 INCH REBAR WITH "BIEDENBACH" CAP) AT 96.06 FEET AND 275.66 FEET;
