- 4.) South 73 degrees 54 minutes 11 seconds East, 106.79 feet to a point;
- 5.) Along a non-tangent curve to the right, with a delta angle of 86 degrees 18 minutes 57 seconds, an arc length of 228.96 feet, a radius of 151.98 feet, and a chord which bears South 36 degrees 21 minutes 56 seconds East, 207.92 feet;
- 6.) South 01 degrees 07 minutes 42 seconds West 38.85 feet to a point;
- 7.) South 12 degrees 45 minutes 56 seconds East, 93.09 feet to a point;
- 8.) South 15 degrees 26 minutes 18 seconds East, 146.98 feet to a point in the centerline of Clay Pike, (Co. Rd. 368, R\W 40'), from which an iron pin found bears North 52 degrees 24 minutes 34 seconds East, 30.96 feet;

Thence along the centerline of said Clay Pike, the following two courses:

- 1.) Along a non-tangent curve to the right with a delta angle of 4 degrees 26 minutes 58 seconds, an arc length of 473.12 feet, a radius of 6092.27 feet, an a chord which bears South 79 degrees 33 minutes 47 seconds West, 473.00 feet to a point;
- 2.) South 85 degrees 41 minutes 00 seconds West, 6.03 feet to a point on the southeast corner of lands presently owned by Dana and Holly A. Lake, OR 2191-232;

Thence along the east line of said Lake lands, North 02 degrees 45 minutes 40 seconds West, 809.58 feet to an iron pipe found on a south corner of lands presently owned by Jay and Megan McDaniel, (OR 3098-920), passing an iron pin found at 25.01 feet, and iron pipes found at 316.93 feet, and 687.55 feet;

Thence along said McDaniel's south line South 70 degrees 59 minutes 15 seconds East, 53.27 feet to the principal place of beginning, passing an iron pin found at 41.00 feet, containing 5.53 acres, more or less, and being part of Auditor's Parcel Number 53-01-06-01-000.
