- #109- THENCE North 16 degrees 28 minutes 03 seconds East 258.68 feet continuing along said road and properties to an unmarked point;
- #110- THENCE North 19 degrees 52 minutes 49 seconds East 172.76 feet along the chord of a curve to the right having, a radius of 1451.00 feet, and arc length of 172.86 feet continuing along said road and properties to an unmarked point;
- #111- THENCE North 23 degrees 17 minutes 36 seconds East 291.48 feet continuing along said road and properties to an unmarked point;
