Legal Description 2.005 Acres

Part Gary C. & Barbara Ann Emerson Parcel: O.R. Book 1093, Page 248

Situated in the Township of Salem, County of Muskingum, State of Ohio, and being part of the Southwest Quarter of Section 5 in the Second Quarter, Township 2N, Range 6W, of the United States Military Lands, and being more particularly described as follows;

Being a Survey of a part of a 146.55 Acre parcel conveyed to Gary C. & Barbara Ann Emerson, as recorded in O.R. Book 1093, Page 248, in the Muskingum County Deed Records, also being part of Auditor's P.P.N. 56-01-05-07-000, and further described as follows;

Commencing at a concrete O.D.N.R. Monument found at the Northwest corner of the Southwest Quarter of Section 5:

Thence, S 01°50'32" W 1367.24 feet with the wWest line of the Southwest Quarter of Section 5, to a point in the centerline of Mollies Rock Road;

Thence, N 57°05'46" E 60.24 feet with the centerline of Mollies Rock Road, to a mag spike set marking the **PRINCIPAL PLACE OF BEGINNING** of the **2.005 Acre** parcel herein to be described;

Thence leaving Mollies Rock Road with a line across said parcel conveyed to Emerson, of which this description is a part, with the following three (3) courses and distances:

- 1) N 01°50'32" E 534.41 feet to an iron pin set, and passing over an iron pin set at 30.00 feet;
- 2) S 88°09'28" E 171.18 feet to an iron pin set;
- 3) S 01°50'32" W 492.50 feet to a mag spike set in the centerline of Mollies Rock Road, and passing over an iron pin set at 462.50 feet;

Thence with the centerline of Mollies Rock Road, with the following three (3) courses and distances:

- 1) S 81°51'07" W 56.94 feet to a point;
- 2) S 79°09'14" W 78.26 feet to a point;
- 3) S 70°53'19" W 41.51 feet to the PRINCIPAL PLACE OF BEGINNING.

Said parcel as surveyed contains 2.005 Acres, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The bearings of the above description are based using the O.D.O.T. CORS Network System, Ohio State Plane Coordinates South Zone. 2011(NAD83)

All iron pins set are 5/8" o.d. iron pins 30" long with red caps labeled "S.A. ENGLAND #S-7452".






