recorded in Deed Book 583, page 30 of the Records of Muskingum
County, Ohio; thence along the south line of said 2.21 acre parcel
south 84 degrees 57 minutes east 318.09 feet to a point in the
center of State Route #93 (Adamsville Road); thence along said
road south 22 degrees 18 minutes west 398.71 feet to a point
in said centerline and the true place of beginning of the premises

centerline south 22 degrees 18 minutes west 130 feet to a point


