Situated in the State of Ohio, County of Muskingum, Township of Salt Creek, being part of the southwest quarter of Section 10, T13, R12, Congress Lands East of The Scioto River and Being part of the lands now owned James L. Eck & Anna A. Eck, Trustees of the James L. Eck & Anna A. Eck Living Trust as recorded in DR 1075-520 of the Muskingum County Recorder's Office and being more particularly described

Beginning at a stone found at the southwest corner of said Section 10, thence N 63°47'17" E a distance of 971.29 feet to a point in the center of Chandlersville Road (SR-146), where it intersects Wolfe Run Road (T-106), the principal place of beginning;

Thence with the center of said Wolfe Run Road the following ten (10) courses:

- 1. N 14°59'03" E a distance of 21.75 feet to a point;
- 2. N 02°41'59" E a distance of 30.40 feet to a point;
- 3. N 06°38'22" W a distance of 42.21 feet to a point;
- 4. N 10°34'32" W a distance of 58.59 feet to a point;
- 5. N 10°37'15" W a distance of 31.88 feet to a point;
- 6. N 10°49'45" W a distance of 373.74 feet to a point;
- 7. N 10°35'32" W a distance of 141.28 feet to a point;
- 8. N 10°38'05" W a distance of 57.78 feet to a point;
- N 08°09'16" W a distance of 82.17 feet to a point;
- 10. N 07°08'37" W a distance of 72.05 feet to a point;
- 11. N 03°18'19" W a distance of 130.07 feet to a point, said point being the southwest corner of the lands now owned by Jason N. Tom & Deborah J. Eck (OR 1506-660);

Thence leaving the center of said Wolfe Run Road and going with the south line of said Tom & Eck's lands the following four (4) courses:

- 1. N 72°25'10" E a distance of 114.50 feet to a point;
- 2. N 88°16'20" E a distance of 35.42 feet to a point;
- 3. S 71°50'50" E a distance of 127.35 feet to a point;
- 4. S 88°36'00" E a distance of 41.16 feet to an iron pin found (harkness) on said Tom & Eck's southeast corner;
