DESCRIPTION
(6.10 10.4)

Situated in the Township of Salt Creek, County of Wayne, State of Ohio.

Being a part of the northwest quarter of Section 20, Township 13, Range 10 of the United States Congress Lands West of the Scioto River, bounded and described as follows:

Commencing at the northwest corner of said Section 20; thence along the following eight courses and distances of roads to the southwest corner of a 14.19 acre tract now owned by Fred L. and Sandra K. Middle:

- (1) S 35°30' E (1188') along the north line of said section to a point;
- (2) S 22°30' W (79.2') to a point;
- (3) S 5° E (296.6') to a point in the center of the road;
- (4) S 52°30' E (104.3') along said road to a point;
- (5) S 17°30' E (223.1') in said road;
- (6) S 42°00' E (223.2') to a point in the center of said road;
- (7) S 31°06' E (691.3') to a point;
- (8) S 32°45' W (200') to the southwest corner of said 14.19 acre tract;

Thence S 77°0'0" E (511.35') along the south line of said 14.19 acre tract to an iron pin at the place of beginning of the following described tract; thence N 74°47'10" E (35.70') to an iron pin; thence S 65°41'33" E (202.67') to an iron pin; thence N 33°12'09" E (33.37') to an iron pin; thence N 60°37'12" E (51.57') to an iron pin; thence N 69°36'43" E (193.46') to an iron pin found; thence S 76°12'10" E (226.79') to an iron spike at the intersection of the centers of Mast Road and Salt Creek Drive; thence S 24°30'49" W (541.26') to an iron spike in the center of Salt Creek Drive; thence N 17°52'0" W (517.0') to the place of beginning, passing over an iron pin at (17.42'). Containing .18 acres or thereabouts.

Subject to the right of way of Mast Road and the right of way of Salt Creek Drive.


