of 1306.35 feet to an iron pin; thence south 87 degrees 55 minutes 39 seconds east
along the northerly line of L. Wells and recorded in deed book 444, page 395 of
the deed records of said county a distance of 1445.00 feet to an iron pin at the
true place of beginning for the parcel herein intended to be described; thence
north 06 degrees 50 minutes 05 seconds east a distance of 255.00 feet to an iron
pin; thence south 87 degrees 05 minutes 23 seconds east a distance of 713.38
feet to a point in Burnt Mill Road and passing through an iron pin at 680.07 feet;
thence south 08 degrees 48 minutes 40 seconds east along said road a distance of
91.87 feet to a point; thence south 30 degrees 33 minutes 08 seconds west along
said road a distance of 174.60 feet to a point; thence north 87 degrees 55 minutes
39 seconds west along the northerly line of C. McConaha and recorded in deed book
575, page 672 of the deed records of said county a distance of 668.56 feet to
the true place of beginning and passing through an iron pin at 35.00 feet, containing
Four and Seven (4.07) hundredths acres more or less.


