

**DESCRIPTION OF SURVEY FOR WADE & JANET HERRON
JOB#2737 Salt Creek Twp**

- #9- THENCE with a curve to the right having, a chord bearing South 49 degrees 10 minutes 03 seconds West 164.06 feet, a radius of 1336.90 feet, and arc length of 164.16 feet continuing along said road and properties to an unmarked point from which an iron pin (found capped 6885) bears for reference North 74 degrees 18 minutes 49 seconds East 42.23 feet;**
- #10- THENCE South 52 degrees 41 minutes 07 seconds West 173.41 feet** continuing along said road and properties to an unmarked point;
- #11- THENCE with a curve to the right having, a chord bearing South 53 degrees 55 minutes 03 seconds West 69.69 feet, a radius of 1620.40 feet, and arc length of 69.70 feet continuing along said road and properties to an unmarked point on the common line for Lots 1 and 8 of said Section 13;**
- #12- THENCE North 87 degrees 28 minutes 09 seconds West 182.57 feet** leaving said road, continuing along said properties and along said Lot line, and along the common line for Lots 2 and 7 of said Section 13 to an iron pin (found capped 6885) at a corner of the Nancy Tom property recorded in Deed Book Volume 1039, Page 67, passing an iron pin (set) at 28.70 feet;
- #13- THENCE North 61 degrees 05 minutes 35 seconds West 323.51 feet** into Lot 2 and along a common line for said Herron and Tom properties to an iron pin (found capped 6885) at a corner of the William M Starr property recorded in Official Record Volume 2964, Page 3;
- #14- THENCE North 24 degrees 36 minutes 59 seconds East 1007.94 feet** along a common line for said Herron and Starr properties and for the Michael D Allen property recorded in Official Record Volume 2823, Page 442 to an iron pin (found capped 6885) on the common line for Lots 1 and 2;
- #15- THENCE North 02 degrees 21 minutes 58 seconds East 314.31 feet** along said Lot line and continuing along said Herron and Allen properties to an iron pin (found capped 6885);
- #16- THENCE North 22 degrees 37 minutes 47 seconds East 1376.08 feet** crossing Lot 1, continuing along said properties, and along the Patricia A Lydic and James C Lydic property recorded in Official Record Volume 2317, Page 68, and the Brian Adam Taylor property recorded in Official Record Volume 2314, Page 819 to an iron pin (found capped 6886) on the common line for Sections 12 and 13 of Salt Creek Township, passing iron pins (found capped Ward) at 259.90 feet and 619.89 feet;
- #17- THENCE South 87 degrees 33 minutes 35 seconds East 856.73 feet** along said Section line and common line for said Wade and Janet Herron property and for the Keith N Herron property recorded in Official Record Volume 2664, Page 172, and a second Wade H Herron and Janet I Herron property recorded in Official Record Volume 1546, Page 401 to the place of beginning, passing an iron pin (found capped 6885) at 77.46 feet, **continuing 67.74 acres**, 0.60 acres of which are within the right of way for Pryor Road (Township Road 654).
