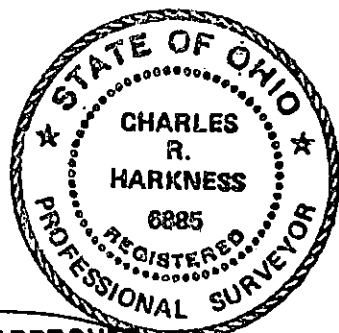


**DESCRIPTION OF SURVEY JOB#2730
FOR JAMES E KELLY Jr. & SANDRA J BEEM (AKA SANDRA J KELLY)**

- E2- THENCE South 51 degrees 04 minutes 07 seconds West 154.43 feet** continuing through said parcel to an iron pin (set);
- E3- THENCE South 44 degrees 10 minutes 54 seconds West 81.21 feet** continuing through said parcel to an iron pin (set);
- E4- THENCE South 41 degrees 16 minutes 37 seconds West 192.22 feet** continuing through said parcel to an unmarked point;
- E5- THENCE South 35 degrees 47 minutes 25 seconds West 99.94 feet** continuing through said parcel to an iron pin (set) at a corner of said parcel;
- E6- THENCE North 25 degrees 49 minutes 08 seconds West 28.42 feet** along a line of said parcel to an unmarked point;
- E7- THENCE North 35 degrees 47 minutes 25 seconds East 87.63 feet** through said parcel to an iron pin (set);
- E8- THENCE North 41 degrees 16 minutes 37 seconds East 194.04 feet** continuing through said parcel to an unmarked point;
- E9- THENCE North 44 degrees 10 minutes 54 seconds East 83.34 feet** continuing through said parcel to an unmarked point;
- E10- THENCE North 51 degrees 04 minutes 07 seconds East 145.73 feet** continuing through said parcel to a cotton gin spike (set);
- E11- THENCE North 06 degrees 39 minutes 28 seconds East 301.25 feet** continuing through said parcel to an unmarked corner of an easement recorded in Official Record Volume 1722, Page 811;
- E12- THENCE South 83 degrees 20 minutes 32 seconds East 25.00 feet** continuing through said parcel and along said easement to an unmarked point on the Kelly/Beem property recorded in Official Record Volume 1722, Page 811;
- E13- THENCE South 06 degrees 39 minutes 28 seconds West 245.20 feet** along a common line for said Parcel and Kelly/Beem property to the place of beginning.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins(set) are 5/8" rebar 30 inches long with identification caps (C.R.Harkness P.L.S.6885). Iron pins (found) are 5/8" rebar unless otherwise noted.
