Ball, and Sharalyn D. Baker, (OR 2707-426), and being the principal place of beginning, and passing an iron pin found at 119.53 feet;

Thence along the west line of said Ball, and Baker lands, South 17 degrees 31 minutes 57 seconds West, 165.00 feet to an iron pin set, on the northeast corner of lands presently owned by William O. and Clara Sue Ault, Trustees, (OR 2759-692);

Thence along the north line of said Ault lands, North 72 degrees 57 minutes 19 seconds West, 95.32 feet to an iron pin set, on the southeast corner of lands presently owned by James A. Dover, (DR 980-451);




