Michael D. Wilson & Galen D. Wilson, Life Estate, Etal OR 3149-377 Part of: 60-80-33-20-000 +/-59.113 Ac. Parcel One

Situated in the State of Ohio, County of Muskingum, Township of Salt Creek and being part of the Southeast Quarter of Section 33, T13, R12, also being part of the lands now owned by Michael D. Wilson & Galen D. Wilson, Life Estate, Etal as recorded in OR 3149-377 of the Muskingum County Recorder's Office and more particularly described as follows.

Beginning at a concrete monument found at the northwest corner of said Southeast Quarter of Section 33, thence with the mid-section line, S 87°53'04" E a distance of 1244.13 feet to a point in the center of Cutler Lake Road (CR-45), passing an iron pin set at 1222.01 feet;

thence with the center of said Cutler Lake Road the following eight (8) courses:

- 1. with a curve turning to the left with an arc length of 155.34 feet, with a radius of 396.48 feet, with a chord bearing of S 09°36'47" W a distance of 154.35 feet to a point;
- S 02°27'43" E a distance of 44.57 feet to a point;
- 3. S 05°46'47" E a distance of 44.01 feet to a point;
- 4. with a curve turning to the left with an arc length of 187.59 feet, with a radius of 166.80 feet, with a chord bearing of S 40°28'25" E a distance of 177.86 feet to a point;
- 5. S 70°40'16" E a distance of 114.17 feet to a point;
- 6. with a curve turning to the right with an arc length of 109.13 feet, with a radius of 172.29 feet, with a chord bearing of S 50°38'27" E a distance of 107.31 feet to a point;
- S 31°11'23" E a distance of 434.51 feet to a point;
- 8. S 26°03'20" E a distance of 133.81 feet to a gin pin set at a northern corner of the lands now owned by the Muskingum County Commissioners (OR2589-394);

thence with the common line of said Wilson, Life Estate, Etal/Muskingum County Commissioners lands the following five (5) courses:

- 1. S 65°32'02" W a distance of 37.31 feet to an iron pin set;
- 2. S 24°27'58" E a distance of 45.69 feet to an iron pin set;
- S 22°09'36" E a distance of 107.50 feet to an iron pin set;
- 4. S 19°24'36" E a distance of 54.14 feet to an iron pin set;
- 5. N 70°35'24" E a distance of 39.99 feet to a gin pin set in the center of said Cutler Lake Road;

thence with the center of said Cutler Lake Road the following four (4) courses:

- S 19°25'06" E a distance of 81.53 feet to a point;
 S 21°28'06" E a distance of 35.52 feet to a point;
- 3. S 23°56'04" E a distance of 112.63 feet to a point;
- with a curve turning to the right with an arc length of 181.51 feet, with a radius of 1067.21 feet, with a chord bearing of S 13°09'43" E a distance of 181.29 feet to a point at the northeast corner of the lands now owned by Carlos D. Clapper & Beverly E. Clapper (OR 1879-219);

thence with the north line of said Clapper's lands, N 87°53'04" W a distance of 2101.03 feet to an iron pin set on the mid-section line, being said Clapper's northwest corner and the east line of the lands now owned by State
