Situated in the State of Ohio, County of Muskingum, Township of Salt Creek, Section 35, T13, R12 and Township of Blue Rock, Section 2, Township 12, Range 12, also being part of the lands now owned by Donald J. Janicki & Mary L. Janicki (DR 1108-69) of the Muskingum County Recorder more fully described as follows.

Beginning at a stone found at the northeast corner of the south east quarter of Section 35, thence with the common line of Sections 35 & 36, Salt Creek Township, S 03°13'33" W, 2627.89 feet to an iron pin found at the common corner of Sections 35 & 36, Salt Creek Township, T13, R12 and Sections 2 & 1, Blue Rock Township, T12, R12;

thence with the common line of said Sections 2 & 1, S 01°35'54" W, 166.42 feet to an iron pin found at the northeast corner of the lands now owned by Michael J. Christie & Jessica L. Christie (OR 2542-926), passing a stone found at 24.91 feet;

thence with the common line of said Janicki/Christie's lands the following two (2) courses:

1. S 68°40'54" W, 628.17 feet to an iron pin found;
2. S 73°33'30" W, 312.16 feet to a point in the center of Sugargrove Road (CR-97), passing an iron pin found at 290.53 feet;

thence with the center of said Sugargrove Road, and through said Janicki's lands the following nine (9) courses:

1. N 11°32'50" W, 210.94 feet to a point;
2. N 09°03'28" W, 109.59 feet to a point;
3. N 01°42'35" E, 105.13 feet to a point;

3. N 63°56'29" E, 254.69 feet to an iron pin set;
4. N 58°55'27" E, 180.94 feet to an iron pin set;
5. N 07°17'05" W, 379.25 feet to an iron pin set;
6. S 80°36'38" W, 187.73 feet to an iron pin set;
7. S 32°49'11" W, 161.12 feet to an iron pin set;
8. S 65°01'26" W, 377.88 feet to an iron pin set on the east line of the lands now owned by Alicia Sweeney (OR 2611-860);

thence with the west line of said Janicki's lands the following two (2) courses:

1. N 29°00'54" W, 209.22 feet to an iron pin found;
2. N 03°04'17" E, 1514.75 feet to an iron pin found on the mid-section line of Section 35, Salt Creek Township, also being on the south line of Ronald D. Kelso & Mallory K. Kelso (OR 2615-702);

thence with said mid-section line, S 87°13'28" E, 1288.55 feet to the place of beginning, containing a total of 74.306 acres more or less, subject to all legal highways and easements of record.

Appended to the above described parcel is an easement for the purpose of ingress/egress, forty feet in width (40') and the centerline of said easements four (4) courses are described as follows :

1. *Beginning at a point that is S 28°44'11" E, 20.00 feet from the beginning of L10 on the attached plat, thence N 61°28'20" E, 98.91 feet to a point;*

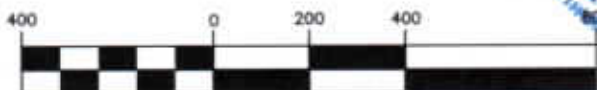
