SURVEY DESCRIPTION
FOR
W. H. BARKER, INC.
PARCEL 1

Part of Auditors Parcel

Situated in the Village of South Zanesville, Muskingum County, Ohio. Being part of the vacated portion of East King Street, originally recorded in plat of the Town plat of South Zanesville (P.B. 2, Pg. 96) and being described as follows:

Beginning at a set rebar set in the Northwest corner of relocated East King Street;

Thence, **N.23°09'18"E.** a distance of **12.96 feet** along the East line of Maysville Pike to a point;

Thence, **S.66°53'44"E.** a distance of **360.06 feet** through the old centerline of East King Street to a point on the West line of Conrail;

Thence, **S.12°26'52"W.** a distance of **13.19 feet** along said rail road lands to a set rebar;

Thence, **N.66°53'44"W.** a distance of **362.51 feet** through the North line of a 0.06 acre parcel and along the North line of the relocated East King Street to the point of beginning.

The above described parcel contains **0.11 acres**, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


