Goff Volume 1149, page 82, 1041.38 feet to an iron pin found; Thence North 89°52'35" East along C. Goff to an iron pin found the place of beginning; Thence North 04°35'34" East along C. Goff 823.58 feet to an iron pin found; Thence North 84°43'12" East 656.79 feet to an iron pin found; Thence South 00°07'25" East 277.20 feet to an iron pin found; Thence along Jason James Volume 1880, page 309, the following four courses and distances – South 18°57'05" West 398.50 feet to an iron pin found, North 85°10'19" West 336.79 feet to an iron pin found, South 05°57'50" East 241.11 feet to an iron pin found, and South 41°19'45" East 259.12 feet to an iron pin found and South 36°54'42" East 32.54 feet to a point in the center of 50 foot road way (Township Road 1742) Thence along the center of said road South 13°16'59" West 65.10 feet to a point; Thence leaving said road way and along the split lines of Fred Stemm, the following two courses and distances – North 36°54'42" West 282.54 feet to an iron pin found passing an iron pin found at 32.54 feet and North 81°37'03" West 289.70 feet to the place of beginning containing 10.81 Acres more or less.


Bearings are based on the midsection line bearing South 89°52'36" West.


