Being a part of the Northeast Quarter of Section 18, Township 16, Range 14 bounded and described as follows:

Commencing at a stone found at the southwest corner of the northeast quarter of Section 18; thence along the west line of said northeast quarter north 2 degrees 55 minutes 14 seconds east 997.85 feet to a point in the center of Coopermill Road and the true place of beginning of the premises herein intended to be described; thence continuing north 2 degrees 55 minutes 14 seconds east 320.0 feet to an iron pin; thence south 87 degrees 04 minutes 46 seconds east 216.61 feet to an iron pin; thence south 2 degrees 55 minutes 14 seconds west 397.75 feet to a point in the center of Coopermill Road; thence along the center of Coopermill Road north 67 degrees 20 minutes 01 seconds west 230.14 feet to the true place of beginning, containing one and seventy-nine hundredths (1.79) acres more or less.

Subject to the easements of Coopermill Road.


