

DESCRIPTION OF SURVEY FOR MEADOW FARM CHURCH

Situated in the State of Ohio, County of Muskingum, Township of Springfield;


Being part of the Northwest Quarter, of Section #17, Township #16, Range #14, of the Congress Lands East of the Scioto River, being part of the prior deed reference Volume 595, Page 102, of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 62-62-39-01-11-000, and more particularly described as follows;

Commencing at a stone (found) at the Southwest Corner, of the Northwest Quarter, of Section #17; thence N 01 12 00 E 174.07 feet along the West line of Section #17, to a Railroad Spike (found) in the Center line of Coopermill Road (Co. Rd. #71), also being the place of beginning for the property herein intended to be described;

- #1- thence N 01 12 00 E 20.24 feet continuing along the West line of said Section #17 to an iron pin (set) at a corner of the Meadow Farm Church Property;
- #2- thence S 88 48 00 E 30.71 feet along a line of said church property to an iron pin (set);
- #3- thence N 01 12 00 E 195.01 feet along a line of said church property to an iron pin (set);
- #4- thence N 88 48 00 W 30.71 feet along a line of said church property to the West line of said Section #17, passing an iron pin (set) at 25.71 feet;
- #5- thence N 01 12 00 E 39.60 feet along the West line of said Section #17 to an iron pin (set) at a corner of said church property;
- #6- thence N 01 12 00 E 77.03 feet continuing along said West line of Section #17;
- #7- thence S 88 48 00 E 39.69 feet through said prior deed reference to an iron pin (set);
- #8- thence S 02 20 15 E 122.29 feet continuing through said prior deed reference to an iron pin (set);
- #9- thence S 01 32 00 W 110.29 feet continuing through said prior deed reference to an iron pin (set);
- #10- thence S 02 58 10 W 99.59 feet continuing through said prior deed reference to the center line of said road, passing an iron pin (set) at 81.56 feet;
- #11- thence N 88 48 00 W 43.52 feet along said road to the place of beginning containing 0.21 acres.

The bearings within the description are based on the West line of Section #17, as surveyed by W.J. Biedenbach RS #5718, and described in deed reference Volume 838, Page 180. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).




