

DESCRIPTION OF SURVEY FOR DALE LAUNDER

Situated in the State of Ohio, County of Muskingum, Township of Springfield, Southeast Quarter, of Section #16, and Southwest Quarter, of Section #15, of Township #16, Range #14, of the Congress Lands East of the Scioto River;

Being part of the prior deed reference Volume 1002, Page 139 of said county's deed records, also being part of Muskingum County Auditor's Parcel Numbers 62-62-47-01-11-000 covering Parcel #1 of said prior deed reference and 62-62-43-01-11-000 covering Parcel #2 of said prior deed reference, and more particularly described as follows;

- Commencing at an axle (found) at the common corner at the Southwest corner of said Section #15, and the Southeast corner of said Section #16; thence along the common line with said Sections N 03 05 35 E 1,285.90 feet to the place of beginning for the property herein intended to be described, also being in the center of County Road #125 (Pinkerton Road);
- #1- thence along the center of said road and through said Section #16 N 63 51 15 W 26.22 feet to the South line of the property known as the Springfield Township School Lot, from which a railroad spike (found) at the Southwest corner of said School Lot bears N 78 47 28 W 64.00 feet;
 - #2- thence along the South line of said School Lot S 78 47 28 E 51.50 feet to an iron pin (found) at the Southeast corner of said School Lot, passing an iron pin (found) on said Section line at 24.37 feet;
 - #3- thence along the East line of said School Lot N 12 50 31 E 99.00 feet to an iron pin (found) at the Northeast corner of said School Lot;
 - #4- thence along the North line of said School Lot N 78 47 28 W 115.50 feet to an iron pin (found) at the Northwest corner of said School Lot, passing an iron pin (found) on said Section line at 44.06 feet;
 - #5- thence along the West line of Parcel #2 of said prior deed reference N 12 50 31 E 417.67 feet to a stone (found) on said Section line;
 - #6- thence through said Section #15 and along the North line of said prior deed reference S 68 38 48 E 755.70 feet to an iron pin (found);
 - #7- thence through said Parcel #1 of said prior deed reference S 07 47 36 W 509.72 feet to the center of said road, passing an iron pin (set) at 483.99 feet;
- thence along the center of said road the following four courses-
- #8- N 68 31 42 W 128.23 feet to a point, from which an iron pin (set) for reference bears N 21 28 18 E 25.00 feet;
 - #9- N 71 05 03 W 355.04 feet to a point, from which an iron pin (set) for reference bears N 20 56 23 E 25.00 feet;
 - #10- N 69 03 37 W 115.92 feet to a point, from which an iron pin (set) for reference bears N 20 56 23 E 25.00 feet;
 - #11- N 63 51 15 W 111.13 feet to the place of beginning containing 0.344 acres of Parcel #2 of the prior deed reference, and 8.393 acres of Parcel #1 of said prior deed reference, for a total 8.737 acres.

The bearings within this description are based on iron pins (found), from a previous survey completed by Charles R. Harkness RS #6885, January 22, 1988, on the property described in deed book Volume 1002, Page 139. Iron pins (set) are 5/8" rebar with aluminum identification caps (C.R.Harkness R.S.6885).




