Commencing at the Southwest corner of the Northwest Quarter of Section 6; thence North $89^{\circ} 15' 00''$ East 1073.04 feet to a point in center of Township Road 90, the place of beginning, passing an iron pin found at 989.78 feet; thence along the center of Township Road 90 (Slack Road) and along Anna M. Jenkins, Vol. 826, Page 201 and T. L. Jenkins, Vol. 826, Page 199, the next five (5) courses and distances, North $74^{\circ} 17' 00''$ East ~~49.84~~ 49.84 feet to a point, North $63^{\circ} 08' 00''$ East 67.45 feet to a point, North $55^{\circ} 31' 00''$ East 58.12 feet to a point, North $46^{\circ} 16' 00''$ East 357.57 feet to a point and North $52^{\circ} 56' 53''$ East 101.06 feet to the intersection of Wesley Chapel Road; thence along center of Wesley Chapel Road and C. W. & E. R. Norris, Vol. 741, Page 134, the following three (3) courses and distances, South $05^{\circ} 08' 00''$ West 164.86 feet to a point, South $04^{\circ} 43' 00''$ East 94.73 feet to a point and South $13^{\circ} 07' 00''$ East 121.25 feet to a point; thence leaving Wesley Chapel Road and along the Newton Township line South $89^{\circ} 15' 00''$ West 517.11 feet to the place of beginning, passing an iron pin set at 28.35 and 454.71 feet, containing 1.89 acres more or less.
