Wilkes Vol. 1123, Page 360, 294.85 feet to an iron pin set; Thence continuing along Raymond H. Wilkes and North Line of a 25.00 foot right of way South 75°06'47" West 125.63 feet to an iron pin found; Thence North 11°13'10" West along Raymond H. Wilkes Vol. 1067, Page 204, 37.65 feet to an iron pin found; Thence North 10°42'30" West along Raymond H. Wilkes Vol. 1123, Page 360, 54.97 feet to the place of beginning containing 0.75 Acres more or less.

Also the right to use the exist 25.00 foot right of way for access to Bradford Court Drive.


Iron pins set are number 5 reinf. bars 30 inches long with plastic ID caps.
