Situated in the State of Ohio, County of Muskingum, Township of Springfield, bounded and described as follows:

Being a part of the Northwest Quarter of Section 1, Township 15 North, Range 14 West and being a part of Spires Subdivision as the same is designated and delineated on Muskingum County Plat Book 8, Page 13, and being more particularly described as follows;

Being all of Lot 8 of said Spires Subdivision, **EXCEPTING THEREFROM, the following described parcel:**

Beginning at an iron pipe found on the northwest corner of said Lot 8 of Spires Subdivision; thence with the north line of said Lot 8 South 84 degrees 56 minutes 00 seconds East 70.31 feet to an iron pin set and the principal place of beginning; thence continuing along the north line of said Lot 8 and the west line lands now owned by C.E. Swingle (DR 842-192) South 84 degrees 56 minutes 00 seconds East 8.09 feet to an iron pipe found on the northeast corner of said Lot 8; thence along the east line of said Lot 8 South 55 degrees 39 minutes 33 seconds West 10.44 feet to an iron pin found; thence through said Lot 8 North 04 degrees 55 minutes 03 seconds East 6.63 feet to the principal place of beginning; containing 0.001 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Iron pins set are 5/8 inch diameter by 30 inch long rebar capped with a plastic identification cap.

Bearings are based on the north line of Meriam Avenue as the same is designated and delineated on Muskingum County Plat Book 8, Page 13, as bearing North 34 degrees 29 minutes West.

This description is written based on an actual field survey completed on November 15, 2000 by Jack D. Newcome, Reg. No. 7321.





