East 246.80 feet; thence North  $2^{\circ} 46' 02''$  West 264.56  
feet to a railroad spike in Township Road (Raindrop Rd.)  
the place of beginning; thence North  $2^{\circ} 46' 02''$  West  
47.07 feet to the South line of Apostolic Gospel Church  
property; thence along South line of Apostolic Gospel  
Church property North  $88^{\circ} 31'$  East 159.72 feet to an axel;  
thence North  $2^{\circ} 46' 02''$  West 81.18 feet to an iron pin on  
the South line of Old Interurban Railroad right of way;
