- #2- THENCE South 80 degrees 55 minutes 16 seconds East 100.00 feet continuing along said Park and Drive to an iron pin (set);
- #3- THENCE along a curve to the right having, a chord bearing South 09 degrees 04 minutes 44 seconds West 80.00 feet, a radius of 40.00 feet, and arc length of 125.66 feet continuing along said Park and Drive to an iron pin (set);




