PART OF AUDITORS PARCEL
63-09-04-04-000 (1.27 acres)

Situated in the South half of Section 13, T-16, R-14, Village of South Zanesville, Muskingum County, Ohio. Being part of the lands of M/E Properties, LLC conveyed in Deed Book 1888 page 404 of the Muskingum County Deed records, and being described as follows:

Commencing at a concrete monument found in the Northwest corner of the intersection of Maysville Pike and Clay Street; thence, S.24°56'36"W. a distance of 573.20 feet along the West right of way line of Maysville Pike to a set p.k. nail, BEING THE POINT OF BEGINNING;

Thence, S.64°58'50"E. a distance of 43.01 feet through the right of way of Maysville pike and through the lands of M/E Properties, LLC (1888/404) to a point on the old centerline of Maysville pike;

Thence, S.25°01'11"W. a distance of 266.44 feet along said centerline to a point;

Thence, N.64°56'18"W. a distance of 206.93 feet through the lands of M/E Properties, LLC (1888/404) to a set p.k. nail, passing a set p.k. nail at 42.65 feet;

Thence, N.25°00'35"E. a distance of 266.29 feet through said M/E lands to a set p.k. nail;

Thence, S.64°58'50"E. a distance of 163.97 feet through said M/E lands to The point of beginning.

The above described parcel contains 1.27 acres, more or less, and is subject to all legal easements and right of ways.

All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.




SURVEY PLAT FOR M/E PROPERTIES, LLC




CONC. MON.
