SUPERIOR STREET PARTIAL VACATION

Situated in the State of Ohio, County of Muskingum, Village of South Zanesville, bounded and described as follows:

Being a part of Superior Street in the Beechwood Park Addition of the Village of South Zanesville as the same is designated and delineated on Muskingum County Plat Book 2, Page 99 and being more particularly described as follows:

Beginning for reference at an existing iron pipe on the southeast corner of Lot 825 of Beechwood Park Addition, as the same is designated and delineated on Muskingum County Plat Book 2, Page 99 and the southeast corner of lands now owned by Lynn Schoop (DR 1145-485);

thence with the east line of said Lot 825 and the east line of said Schoop's land on a curve to the left having a radius of 204.00 feet, an arc length of 35.59, a central angle of 09 degrees 59 minutes 46 seconds, a chord bearing North 27 degrees 37 minutes 29 seconds West a distance of 35.55 feet to an iron pin set and the principal place of beginning;

thence continuing along said east line of Lot 825 on a curve to the left having a radius of 204.00 feet, an arc length of 117.99, a central angle of 33 degrees 08 minutes 21 seconds, a chord bearing North 49 degrees 11 minutes 33 seconds West a distance of 116.35 feet to a point on the northeast corner of lands now owned by R. and M. Willey (DR 958-23), from which an iron pin found bears South 02 degrees 10 minutes 41 seconds East 2.32 feet;

thence through the right of way of Superior Street at recorded in said Beechwood Park Addition on Muskingum County Plat Book 2, Page 99, the following two courses:

- 1) North 02 degrees 10 minutes 41 seconds West 26.68 feet to an iron pin set;
- 2) North 84 degrees 02 minutes 41 seconds East 70.12 feet to an iron pin set on the west right-of-way Linden Street;

thence along the said right of way of Linden Street, on a curve to the left having a radius of 145.00 feet, an arc length of 114.63 a central angle of 45 degrees 17 minutes 39 seconds, a chord bearing South 09 degrees 58 minutes 32 seconds East a distance of 111.67 feet to the principal place of beginning,

containing 0.08 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.


Iron pins set are 5/8 inch by 30 inch long rebar with a plastic identification cap.

Bearings are based on the south line of Lot 825 as recorded in Muskingum County Deed Record 958-23 as bearing South 61 degrees 40 minutes 00 seconds West.





PLAT OF ROAD VACATION



Bearings are based on the south line of Lot No. 825 as found in DR 958-23, and being S61°40'00"W.


