THENCE WITH THE END OF DIANA DRIVE, NORTH 84 DEGREES 05 MINUTES 57 SECONDS EAST 40.10 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE -DISTURBED) AT THE SOUTHWEST CORNER OF LOT 12;
