COMMENCING AT THE NORTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 2;

THENCE NORTH 87 DEGREES 40 MINUTES 24 SECONDS WEST 203.96 FEET TO A POINT ON THE WEST LINE OF THE 0.281 MORE OR LESS ACRE TRACT CONVEYED TO M. AND P. HAMBEL BY DEED RECORDED IN VOLUME 1017, PAGE 17 OF THE MUSKINGUM COUNTY DEED RECORDS, SAID POINT BEING SOUTH 16 DEGREES 04 MINUTES 49 SECONDS WEST 3.55 FEET FROM AN EXISTING 1/4 INCH PIPE AT THE SOUTHWEST CORNER OF A 1.19 ACRE TRACT CONVEYED TO F. AND J. DRISKEL BY DEED RECORDED IN VOLUME 723, PAGE 238 OF THE SAID COUNTY RECORDS, SAID POINT ALSO BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE WEST AND SOUTH LINES OF THE ABOVE SAID HAMBEL TRACT THE NEXT THREE COURSES AND DISTANCES:

- 1) SOUTH 16 DEGREES 04 MINUTES 49 SECONDS WEST 11.16 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);
- 2) SOUTH 07 DEGREES 08 MINUTES 38 SECONDS EAST 229.17 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);
- 3) NORTH 84 DEGREES 41 MINUTES 29 SECONDS EAST 247.52 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 110 (CHURCH HILL ROAD), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 220.02 FEET;

THENCE WITH THE CENTER OF THE SAID ROAD THE NEXT THREE COURSES AND DISTANCES:

- 1) SOUTH 14 DEGREES 09 MINUTES 17 SECONDS EAST 70.49 FEET TO A POINT;
- 2) SOUTH 18 DEGREES 10 MINUTES 39 SECONDS EAST 97.65 FEET TO A POINT;

THENCE WITH THE SOUTH LINE OF SAID GREEN TRACT, SOUTH 87 DEGREES 40 MINUTES 24 SECONDS EAST 106.00 FEET TO THE PLACE OF BEGINNING.







IRON PIN DETAIL
