Being 27.037 acre, more or less, PARCEL 70-70-15-08-08-000 in the northeast quarter of section 8, in the first quarter of township 1 north, range 7 west, United States Military Lands, and in the township of Washington, in the county of Muskingum, in the state of Ohio and more particularly described as follows:

Beginning at a 5/8" rebar found at the northwest corner of the northeast quarter of section 8, said 5/8" rebar found being the TRUE POINT OF BEGINNING;

thence, with the north line of section 8 the following 2 courses:

1. thence, S.76°31'58"E. 250.00' to a 5/8" rebar found;
2. thence, continuing S.76°31'58"E. 270.19' to a point in Culbertson Road, T.R. 190;

thence, with Bateman Road, T.R. 112, the following 7 courses:

1. thence, S.16°00'34"W. 1052.99' to a point;
2. thence, S.14°30'10"W. 333.75' to a point;
3. thence, S.16°47'10"W. 467.05' to a point;
4. thence, S.13°22'25"W. 540.99' to a point;
5. thence, with a curve to the right having the following properties:
Delta = 65°43'15", R = 200.00', L = 229.41',
L. Chord = S.46°14'02"W. 217.04' to a point;
6. thence, S.79°05'40"W. 69.07' to a point;
7. thence, S.81°51'44"W. 103.60' to a point on the south line of the northeast quarter of section 8;

thence, with the south line of the northeast quarter of section 8, N.76°49'00"W. 132.13' to the southwest corner of the northeast quarter of section 8;

thence, with the west line of the northeast quarter of section 8 the following 2 courses:

1. thence, N.12°46'11"E. 1391.76' to a 5/8" rebar found;
2. thence, N.12°45'22"E. 1251.16' to the TRUE POINT OF BEGINNING, containing 27.037 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.

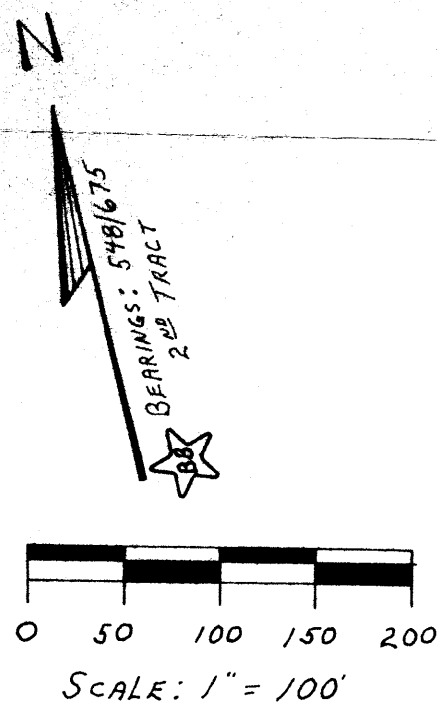

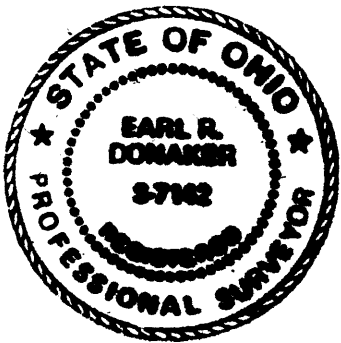
