Commencing at a stone found at the Northwest corner of Section 10; Thence South 02°24'50" West 613.24 feet to a stone found; Thence South 87°29'10" East 843.22 feet to an iron pin; Thence South 87°23'40" East 1384.52 feet to an iron pin set the place of beginning passing an iron pin at 1053.36 and 1019.26 feet; Thence South 87°23'40" East along Lot 1 of Circle E Estates P.B. 15 page 54, 401.59 feet to a point in center of State Route 93 passing an iron pipe found at 371.59 feet; Thence South 03°09'58" West in center of State Route 93 173.03 feet to a point; Thence North 87°23'40" West along P. Murray O.R. Volume 1553, page 201, 397.56 feet to an iron pin set passing an iron pin set at 35.50 feet; Thence along the split lines of Robert P. Norris Deed Volume 1141, page 391, North 01°49'29" East 173.04 feet to the place of beginning containing 1.59 Acres more or less.

Except a 20.00 foot wide right of way along the South line of above description.

Bearings are based on the West line of Section 10 bearing South 02°24'50" West.

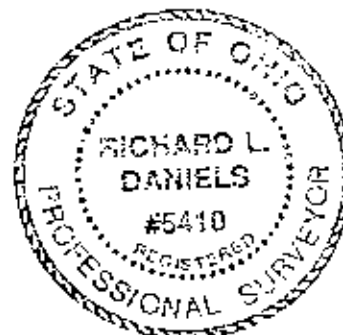
