

DESCRIPTION OF SURVEY FOR HARTLEY COMPANY

Situated in the State of Ohio, County of Muskingum, Township of Washington:

Being part of Lot #2 of Briarcliff Subdivision recorded in Plat Book 11, Page 16, said Lot #2 being a part of the Hartley Company property recorded in deed reference Deed Book Volume 1068, Page 228 of said county's deed records, said Lot #2 known as Muskingum County Auditor's Parcel Number 70-55-01-02-000, and more particularly described as follows;

Beginning at an iron pin (found) at the common Northern corner of Lot #1 and Lot #2 of said Briarcliff Subdivision, also being on the Southeast line of East Pike (US Route #40);

- #1- thence S 43 48 20 E 127.53 feet along the common line for said Lots #1 and #2 to an iron pin (set);
- #2- thence N 47 24 00 W 127.25 feet through said Lot #2 to an iron pin (set) on the Northwest line of said Lot #2 and Southeast line of said East Pike;
- #3- thence N 42 24 00 E 8.00 feet along the said Northwest line of said Lot #1 and Southeast line of US Route #40 to the place of beginning, containing 0.012 acres.






The bearings on this plat are based on the East line of Lots #1 & #2 of Briarcliff as recorded in Plat Book 11, Page 16.
