

**Survey for KJF Enterprises, LLC.**

Being a part of land located in the State of Ohio, County of Muskingum, Washington Township, part of quarter township 3, Township 1 North, Range 7 West, United States Military Lands. Being part of the lands conveyed to KJF Enterprises, LLC. in Deed Record 1759, page 776 Tract 1, Parcel 2, bounded and described as follows:

Commencing at an iron pin found at the northwest corner of Lot 7 of McBride's Addition (Replat Book 1, page 255);

thence along the south line of a vacated 16' wide alley and along the north line of Lot 7 North 79 degrees 03 minutes 33 seconds East 16.39 feet to an iron pin found;

thence continuing along the south line of a vacated 16' wide alley and along the north line of Lot 7 North 79 degrees 03 minutes 33 seconds East 109.29 feet to a point on the east line of a vacated 8' wide alley, the **place of beginning** for this parcel;

thence along the east line of said vacated alley North 12 degrees 26 minutes 27 seconds West 19.59 feet to an iron pin set;

thence leaving the east line of said vacated alley and through KJF Enterprises, LLC. (DR 1759-776, tr.1, prcl.2) the following three courses:

1. North 75 degrees 21 minutes 16 seconds East 235.17 feet to an iron pin set;
2. North 51 degrees 03 minutes 54 seconds East 69.69 feet to an iron pin set;
3. North 12 degrees 10 minutes 11 seconds East 57.34 feet to an iron pin set on a line of The County of Muskingum, Ohio (DR 1135-467, tr.1);

thence along The County of Muskingum, Ohio (DR 1135-467, tr.1) South 11 degrees 41 minutes 49 seconds East 120.00 feet to an iron pin set;

thence along another line of The County of Muskingum, Ohio (DR 1135-467, tr.1) South 75 degrees 21 minutes 16 seconds West 319.93 feet to an iron pin set on the east line of a vacated 8' wide alley;






