THENCE CONTINUING WITH THE SAID WEST LINE, SOUTH 17 DEGREES 37 MINUTES 36 SECONDS EAST 110.68 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE WEST LINE OF EASTLYND ACRES NO. 2 (PLAT BOOK 10, PAGE 45), SOUTH 17 DEGREES 37 MINUTES 36 SECONDS EAST 136.64 FEET TO AN IRON PIN SET;
