Situated in the State of Ohio, County of Muskingum, Township of Washington, being part of the 4<sup>th</sup> Quarter Township, Township 1, Range 7, being all of the lands now owned by M. Joanne Pollock as recorded in DR 1144-962, Parcels No.'s 70-80-01-31-000, 70-80-01-43-000 & 70-80-01-24-000 of the Muskingum County Recorders Office and more particularly described as follows.

Beginning for reference at a point 45 feet right, SR-93 CL Station 28+29.38, as shown on MUS-93-13.03, Page 7 of 11, thence South 74 degrees 58 minutes 22 seconds East, 553.53 feet to a stone found on the southeast corner of the lands now owned by Zemba Farms, Ltd., and the **principal place of beginning**;

thence with said Zemba's line the following three (3) courses:

- 1. North 01 degrees 16 minutes 38 seconds East, 540.54 feet to an iron pin found;
- 2. South 73 degrees 46 minutes 38 seconds West, 205.26 feet to an iron pin found;
- 3. North 68 degrees 43 minutes 22 seconds West, 253.97 feet to a point in the center of Boggs Road (CR-108), passing an iron pin set at 231.50 feet;

thence with the center of said Boggs Road the following three (3) courses:

- 1. North 51 degrees 15 minutes 24 seconds East, 192.56 feet to a point;
- 2. North 47 degrees 48 minutes 12 seconds East, 194.04 feet to a point;
- 3. North 44 degrees 59 minutes 04 seconds East, 104.45 feet to a point, said point also being the northwest corner of the lands now owned by Ohio Rentals, LLC (OR 1880-123);

thence with the southwesterly line of said Ohio Rentals, LLC, **South 45 degrees 16 minutes 16** seconds East, 387.62 feet to a pipe found on the westerly line of the lands now owned by Norman T. & Shirley E. - 2. North 60 degrees 58 minutes 04 seconds West, 187.12 feet to a point in the center of said Boggs Road, passing an iron pin set at 164.78 feet;

thence with the center of said Boggs Road, North 43 degrees 15 minutes 03 seconds East, 26.85 feet to a point on the northwest corner of the lands now owned by Gary E. Littick (OR 1095-103);

thence leaving the center of said Boggs Road and going with the south line of said Littick's lands, South 61 degrees 21 minutes 57 seconds East, 595.80 feet to a point on the west line of the lands now owned by the Ohio District Council of Pentecostal Churches, Inc.
