Being all of Deed Vol. 1127, Page 310, Parcel No. 71-70-80-04-09-000, part of Lot 8 of Lawndale Acres Subdivision recorded in Plat Book 10, Page 20.

Beginning at an Axle found at the Northeast corner of Lot 8 of said subdivision; Thence South 41°59' West along Lot 36, 99.33 feet to an axle found; Thence North 82°31'00" West along P&M Kussmaul Vol. 777, Page 188, and Lot 9 280.51 feet to an 1 1/4" pipe found; Thence on a 3062.65 foot radius curve to the right the chord of which bears North 3°23'05" East along Pleasant Grove Road Right of Way 100.02 feet to an 1/2" pipe found; Thence South 82°23'48" East along R.L.&D Glaub Vol. 759, Page 282 (and Lot 7) 282.09 feet to the place of beginning containing 0.64 acres more or less.

Bearings are based on Plat Book 10, Page 20, South Line of Lot 8 bearing South 82°31'00" East.

Iron pins set are No. 5 Reinf. bars 30 inches long with plastic ID caps.

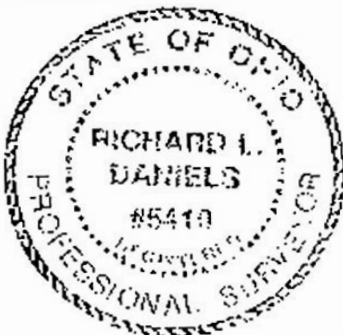
