

Survey for K. Wickham

Being a part of land located in the State of Ohio, County of Muskingum, Township of Washington, and being part of Quarter Township 4, Township 1 North, Range 7 West, bounded and described as follows:

Beginning at an iron pin found 165' right of Interstate 70 Station 83+81.10 and on the west line of Henry Rentals (OR 1127-721);

thence along the west line of Henry Rentals (OR 1127-721) South 05 degrees 32 minutes 22 seconds West 289.57 feet to an iron pipe found;

thence continuing along the west line of Henry Rentals (OR 1127-721) South 05 degrees 32 minutes 22 seconds West 40.17 feet to a point in the centerline of U.S. 40;

thence along the centerline of U.S. 40 South 89 degrees 53 minutes 32 seconds West 89.90 feet to a point;

thence leaving the centerline of U.S. 40 and along the east line of K. & E. Bates (DR 1033-257) North 05 degrees 20 minutes 52 seconds East 40.17 feet to an iron pin found;

thence continuing along the east line of K. & E. Bates (DR 1033-257) North 05 degrees 20 minutes 52 seconds East 269.27 feet to an iron pin found disturbed on the south right of way of Interstate 70;

thence continuing North 05 degrees 20 minutes 52 seconds East 390.94 feet to an iron pin found disturbed on the north right of way of Interstate 70;

thence continuing North 05 degrees 20 minutes 52 seconds East 301.00 feet to an iron pin found at a corner of M.J. Pollock (OR 1144-962);

thence along a south line of M.J. Pollock (OR 1144-962) South 89 degrees 59 minutes 39 seconds East 90.07 feet to an iron pin found at the northwest corner of Henry Rentals (OR 1127-721);

thence leaving the south line of M.J. Pollock (OR 1144-962) and along the west line of Henry Rentals (OR 1127-721) South 05 degrees 24 minutes 50 seconds West 293.16 feet to an iron pipe found on the north right of way of Interstate 70;

thence continuing along the west line of Henry Rentals (OR 1127-721) South 05 degrees 09 minutes 30 seconds West 378.32 feet to the principle place of beginning, containing 2.07 acres, more or less.

(0.80 acres being in Interstate 70 right of way, and 0.08 acres being in U.S. 40 right of way)

Iron pins set are 5/8 inch rebar 30 inches long with identification caps (SWIERZ 8062). This legal description was prepared by Denis P. Swierz Reg. Surv. No. 8062, based on a field survey made in September 2001 by DADECO Engineering.

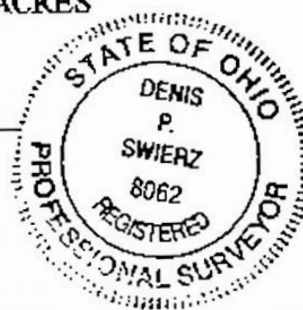

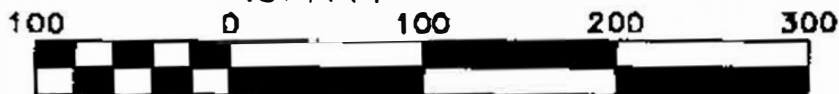
