AND MARY L. DOSCH AS RECORDED IN DEED BOOK 549, PAGE 858 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE SOUTH 84 DEGREES 43 MINUTES 50 SECONDS EAST 209.93 FEET (BY DEED) TO A POINT IN THE SAID CENTER OF COUNTY ROAD NUMBER 42; THENCE NORTH 88 DEGREES 56 MINUTES 30 SECONDS EAST 257.72 FEET (BY DEED) TO A POINT IN THE SAID CENTER OF COUNTY ROAD NUMBER 42; THENCE NORTH 84 DEGREES 43 MINUTES 40 SECONDS EAST 35.40 FEET (BY DEED) TO A POINT IN THE SAID CENTER OF COUNTY ROAD NUMBER 42, SAID POINT BEING THE SOUTHWEST CORNER OF A 0.88 MORE OR LESS ACRE TRACT CONVEYED TO EARL D. AND KATHLEEN M. MARKS AND RECORDED IN DEED BOOK 830 PAGE 331 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE CONTINUING NORTH 84 DEGREES 43 MINUTES 40 SECONDS EAST 201.23 FEET ALONG THE SOUTH LINE OF THE SAID MARK'S TRACT TO A POINT IN THE CENTER OF SAID COUNTY ROAD NUMBER 42, SAID POINT BEING THE SOUTHEAST CORNER OF A 0.93 MORE OR LESS ACRE TRACT CONVEYED TO EARL D. AND KATHLEEN M. MARKS AND RECORDED IN DEED BOOK 812 PAGE 167 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE NORTH 81 DEGREES 44 MINUTES 54 SECONDS EAST 127.21 FEET TO A POINT IN THE SAID CENTER OF COUNTY ROAD NUMBER 42, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE CONVEYED; THENCE NORTH 07 DEGREES 21 MINUTES 14 SECONDS WEST 169.30 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR), PASSING A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR) AT 20.00 FEET; THENCE NORTH 75 DEGREES 54 MINUTES 53 SECONDS EAST 144.33 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR); THENCE SOUTH 15 DEGREES 06 MINUTES 48 SECONDS EAST 178.65 FEET TO A POINT IN THE CENTER OF SAID COUNTY ROAD NUMBER 42, PASSING A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR) AT 158.65 FEET; THENCE SOUTH 79 DEGREES 30 MINUTES 01 SECOND WEST 167.71 FEET TO THE PLACE OF BEGINNING.
