

0.23 Acre Split for Jacqueline S. Grant and Daniel D. Allen

Situated in the State of Ohio, County of Muskingum, Township of Wayne, and being part of of Section 3, Township 12, Range 13, Congress Lands East of the Scioto River, and being part of Lot No. 13, of Sherwood Hills subdivision, as found in Plat Book 13, page 26 of the Muskingum County Records, and presently owned by Jacqueline S. Grant and Daniel D. Allen(OR 1843-759), an being more particularly described as follows:

Beginning for reference at an iron pin found on the Northwest Corner of Lot No. 11 of Sherwood Hills subdivision, found in the Muskingum County Records in plat Book 13, page 26;

Thence along the north line of Lot No.s 11 and 12, North 72 degrees 08 minutes 35 seconds East, 219.12 feet to a point on the northeast corner of lot No. 12, and the principal place of beginning, passing the northwest corner of Lot No. 12 at 100.82 feet;

Thence along the north line of Lot No. 13, and being the lands presently owned by Jacqueline S. Grant, and Daniel D. Allen(OR 1843-759), South 85 degrees 31 minutes 52 seconds East, 41.22 feet to a point;

Thence through said Grant and Allen lands, South 11 degrees 13 minutes 50 seconds East, 176.21 feet to an iron pin set on the north right of way of Clay Pike (Co. Rd. 441);

Thence along said north right of way, South 62 degrees 58 minutes 46 seconds West, 69.31 feet to a point on the southeast corner of Lot No. 12, being lands presently owned by J. A. and A. J. Krouskouff(OR 1153-711);

Thence along the east line of said lot, North 03 degrees 46 minutes 07 seconds West, 207.98 feet to the principal place of beginning, containing 0.23 acres more or less, subject to all legal road right of ways, and easements, written, or implied.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.
